Short Description of Proposed Plan, Activities, and Use of the Prize Funds:

We propose to create a financial model to transform Chama's community center into a place for resilience to extreme events and frequent blackouts. We will plan for the construction of a microgrid with solar panels and battery storage and package together all steps needed to enact the Village of Chama's vision, including renewable infrastructure design, energy efficiency measures, building upgrades, brownfields remediation, and other revitalization needs. We will provide project management, greenhouse gas accounting, and economic projections, leveraging grant funding, tax incentives, and private and community investment options so that Chama will have a broad range of financial mechanisms tailored to their needs despite a lack of capital and internal capacity. By the end of Phase II, Adelante will create and NCNMEDD will share a viable, replicable, and documented financial model and secure funding sources for implementation. We will facilitate a learning cohort to observe Phase II, including the rural county of Mora, New Mexico and at least one other rural community recruited by NCNMEDD. The two communities would receive the same services as proposed for Phase II if we won the Second Round of the prize
