All teams should begin, if you haven't already, working on the identified solution with their utility partner.

Teams should be working with their utility partner throughout this Phase to develop & refine their solutions that addresses the issues their utility partner(s) are facing.











Progress Phase - Prizes

Utility Digitization/Data Challenge Track

Prizes

Up to three winners will win:

- \$200,000 cash each
- \$75,000 national laboratory voucher

Utility Cybersecurity Challenge Track

Prizes

Up to 1 winner will win:

\$300,000 cash

Phase 2: Progress - Submission Details

Materials to Submit

- 1. 90-second video (public)
- 2. Cover page
- 3. Narrative that answers four questions
- 4. One summary PowerPoint slide (public)
- 5. Required letters of commitment or support from utility partner

Where to Submit

- Submit all materials online on the official prize platform HeroX: https://www.herox.com/DigitizingUtilitiesRound2
- Use HeroX to review official Prize Rules, ask questions, and receive updates

Narrative Questions

Question 1: Team & Problem Overview What problem were you trying to solve?	Question 4: Solution Validation How was your solution tested and validated?
Question 2: Solution Implementation Did you achieve the goals identified in the Plan Phase?	Question 5: Future Plans What is the potential impact of your work moving forward?
Question 3: Solution Impact What benefits were provided to the team's utility partner?	Question 6: Voucher Plans

Letters of Support/Commitment

A detailed letter of support from your utility partner is <u>required</u>. It should not be longer than 2 pages.

Your utility partner's letter of support should highlight:

- Your continued relationship with your utility partner (including any solution demonstrations),
- Any progress and successes achieved during the Progress Phase, &
- Your utility partner's ongoing support and their overall experience.

Teams may also optionally include other letters of support/commitment from other relevant entities to provide context.

Teams should not include any general letters of support/commitment that are not critical to the execution of your solution

Demo Day AMERICAN

Demo Day

This is a required event for all competitors, whether competing in the Utility Digitization/Data Challenge Track or the Utility Cybersecurity Challenge Track!

Important Details

- At least one team member from the competitor team must be present at the Demo Day for the team to be considered for a Progress Phase prize.
 - Each team is allotted up to 2 presenters who will each be given presenter access (camera/mic) on the day of the event.
- Teams will have 10 minutes to present:
 - A solution demonstration video (max. 3 minutes)
 - Presentation highlighting progress made and solution developed
- Each presentation will be followed by a public Q&A from the reviewer panel.

Demo Day

Don't Forget

- All Demo Day presentations will be made public. We advise each team to be aware of any information that <u>should not</u> be publicly shared/available.
- Teams are encouraged to invite colleagues and key partners outside of the two presenters to attend and contribute questions to the Q&A portion of your presentation.
- The 10-minute presentation allotment is a hard constraint. (Teams will be cutoff even if they have not finished their presentation.)

Vouchers AMERICAN

Voucher Overview

The Progress Phase winners of the Utility Digitization/Data Challenge Track will be awarded a \$75,000 national laboratory voucher.

Teams should note:

- The national laboratory voucher can only be redeemed at a single national laboratory.
- The voucher must be exclusively dedicated to advancing the competitor's innovation.
- Voucher Statement of Works (SOWs) must be submitted to the Prize team at <u>digitizingutilitiesprize@nrel.gov</u> within 90 days of the Progress Phase Winner Announcement, or teams will lose their voucher.
- Remaining funds cannot be redeemed for cash.

Teams should review the Voucher Guidelines document in under the "Resources" on HeroX, particularly the terms and conditions listed in Appendix B of the official rules document.

Narrative - Voucher

Teams competing in the Utility Digitization/Data Challenge track must address the additional "Voucher Plans" section in their narrative submission within 750 words max.

Suggested narrative content includes:

- What type of work do you intend to complete using the national laboratory voucher?
- What impact will this voucher have on your solution?
- What are the future implications for your team/company if you receive a voucher?
- Briefly describe your potential plans and/or project scopes that you would submit if awarded a national laboratory voucher.
- Describe how both the team and utility will partner to maximize the use of the national laboratory voucher.
- Describe the expected cost-share to be provided by the team and/or utility.

 - Teams must submit all required documents on HeroX before this deadline.
- Demo Day is December 10 at 9 a.m. ET.
- Phase 2 Winners announcements are tentatively scheduled for January 13, 2025.
